

**1500 ESPN- "Garage Logic Podcast Listener Appreciation Party" SWEEPSTAKES
Official Rules**

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

BY ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.

- 1. Eligibility:** The 1500 ESPN "Garage Logic Podcast Listener Appreciation Party" Sweepstakes (the "Sweepstakes") is open only to individuals who are 21 years or older and residents of Minnesota or Wisconsin and who reside within 150 miles of 1500 ESPN's studio located at 3415 University Avenue, St. Paul, MN 55114, to be eligible to win. No purchase necessary to enter the Sweepstakes. Employees of KSTP-AM, LLC and its radio station 1500 ESPN (the "Sponsor"), Summit Brewing ("Promotional Participant"), HBI Radio, LLC, or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Sweepstakes (collectively with Sponsor, the "Released Parties") and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members of each such employee are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. How to Enter:** To enter, visit the 1500 ESPN Facebook page during the Sweepstakes Period, and find "Contest" post to find and complete the entry form, which includes your name, email address, date of birth, state where you reside, zip code, and daytime telephone number. Once you have completed the entry form, click "submit" to be entered into the Random Drawing. Limit one (1) entry per person/email address. All entries must be received by 11:59:59 p.m. CT on December 16, 2018 to be entered into the random drawing.

This Sweepstakes is not sponsored, endorsed, administered by or associated with Facebook. By entering, you are providing your information to Sponsor and not to Facebook.

- 4. Random Drawing:** A random drawing will be conducted on or about December 17, 2018 from among all eligible entries received, to determine the winners. Decisions of judges are final and binding. Odds of winning depend on the number of entries received. Administrator will conduct the random drawing. Winners will be notified by telephone, or email on or about the date of the drawing. Administrator will make up to 3 attempts to contact each winner. If a winner cannot be contacted after 3 attempts, that potential winner will forfeit the prize, and the prize may be awarded to an alternate winner, time permitting.

- Two (2) tickets into the Garage Logic Listener Appreciation Party live podcast broadcast on December 21, 2018 from noon until 2:00 PM CT; one (1) pint from Summit Taproom, one (1) sample of the new "Summit 21" beer, a Grab bag from Summit Brewing, and a Tour of Summing Brewing; ARV: \$50 each. Transportation and parking are not included as part of the prize. The prize will be awarded only if the potential winners fully comply with these Official Rules. If a winner cannot prove he or she is a qualified winner, the prize will not be awarded to that winner. All unclaimed or returned prizes remain the property of Sponsor.

Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner.
