

## **KS95 – FIESTA DEL FUEGO SWEEPSTAKES**

### **OFFICIAL RULES**

1. **HOW TO ENTER:** NO PURCHASE NECESSARY. In order to enter, from 6:00 p.m. on Monday, April 11 2016, through 11:59:59 p.m. on Thursday May 5, 2016, log on to [www.ks95.com](http://www.ks95.com) click on the contest icon "FIESTA DEL FUEGO SWEEPSTAKE" and complete the entry form (which includes your name, address and daytime telephone number). KSTP-FM is not responsible for problems accessing the website, technical or atmospheric conditions that disrupt the completion of the entry, or any other problems which might or might not result from this contest.
