

Official Rules – American Refugee Committee “Month of Thanks – Trip to Uganda for World Refugee Day!” Sweepstakes

**NO PURCHASE NECESSARY.
PURCHASE WILL NOT IMPROVE CHANCES OF WINNING**

1. **How to Enter:** To enter, visit the American Refugee Committee page on Facebook (“Web site”) from 9:00:00 a.m. Central Time (“CT”) on December 4, 2017 until 11:59:59 p.m. CT on January 14, 2018 (“Sweepstakes Period”), find and complete the entry form, which includes your name, email address, date of birth, state where you reside, zip code, and daytime telephone number. Once you have completed the entry form, click “submit” to be entered into the Random Drawing. Limit one (1) entry per person/email address via this method of entry. However, to receive additional entries in the Sweepstakes, upon submitting your entry form, you will be shown options to share the Sweepstakes through Twitter, email or Facebook and for each referred friend who successfully submits and entry form, you will receive one (1) additional entry into the Sweepstakes. All entries must be received by 11:59:59 p.m. CT on January 14, 2018 to be entered into the Random Drawing.

This Sweepstakes is not sponsored, endorsed, administered by or associated with Facebook. By entering, you are providing your information to Sponsor and not to Facebook.

2. **Random Drawing:** A random drawing will be conducted on or about January 15, 2018 from among all eligible entries received to determine the winner. Decisions of judges are final and binding. Odds of winning depend on the number of entries received. Administrator will conduct the random drawing. Winner will be notified by telephone, or email on or about the date of the drawing. Administrator will make up to **3 attempts** to contact each winner. If the winner cannot be contacted after 2 attempts, that potential winner will forfeit the prize, and the prize may be awarded to an alternate winner, time permitting. Potential Grand Prize winner will then be required to complete, sign and return an Affidavit of Eligibility, Liability Release and Publicity Release (where legal) within **10 business days** of winner notification. Winner will also be required to sign and complete a W2 prior to receiving their prize and a 1099 form will be submitted by Sponsor (or Administrator, on behalf of the Sponsor) to all appropriate taxing authorities. These documents may require that you provide your Social Security Number for tax reporting purposes. Non-compliance with this requirement, or if prize/prize notification is returned as non-deliverable, or if any winner is found to be ineligible or not in compliance with these Official Rules, such prize will be forfeited and may be awarded to an alternate winner, time permitting. Upon receipt of all Prize Releases, Sponsor will contact the Grand Prize winner to arrange for travel accommodations.
3. **Prize & Approximate Retail Values (“ARV”): One (1) Grand Prize** – Trip for two (2) people to Uganda for World Refugee Day 5k on June 20, 2018. Trip includes: roundtrip coach airfare from the Sponsor-specified major airport nearest winner’s residence to Uganda; seven (7) nights hotel accommodations for two people (one standard room, double occupancy); ground transportation to/from airport/hotel in Uganda; visa costs

for winner and guest; and breakfast, lunch and dinner each day for winner and guest for seven (8) days; ARV: \$6,000.00. Must present a valid credit card upon check-in at hotel. Alcohol, souvenirs/gifts, medical exam, inoculation/vaccination costs, and any other costs or fees not specified in these official rules are not included as part of the prize and are winner's and winner's guest's sole responsibility. Receiving a medical exam and inoculations/vaccinations are required as a condition to accept the prize and travel to Uganda as the winner and winner's guest. A visa will be required for winner and winner's guest as a condition of receiving the prize and Sponsor will assist winner and winner's guest in obtaining the visa, as well as reimburse winner and winner's guest for any fees associated with receiving a visa to travel to Uganda. A valid passport will also be required to travel. Winner and winner's guest must travel from June 16, 2018 through June 23, 2018 or prize will be forfeited and could be awarded to an alternate, time permitting, unless otherwise agreed to by Sponsor in writing. Prize only consists of the items specifically listed as part of the prize. Winner's travel companion must be at least 21 years of age or older. Winner and travel companion must travel on the same itinerary and have valid passports in order to travel to Uganda. No cash or other substitution allowed by winner, but Sponsor may substitute the prize, or any portion thereof, for a prize of equal or greater value at Sponsor's sole discretion for any reason. The prize is non-assignable and non-transferable. Grand Prize winner is solely responsible for local, state and federal taxes on the prize. Grand Prize winner will be required to sign and complete a W9 prior to receiving their prize and a 1099 form will be submitted by Sponsor to all appropriate taxing authorities.

Void in FL, NY and where prohibited. Employees and directors of American Refugee Committee ("Sponsor"), 2060 Digital, LLC d/b/a Hubbard Interactive (collectively, "Administrator"), Hubbard Radio, LLC, and their respective parents, subsidiaries and affiliated companies, advertising, promotion or production agencies, and their immediate family members or individuals residing in their same household, are not eligible to participate or enter.
