

**Casio Education – Learning Beyond the Classroom Sweepstakes

- When to Enter:** The Sweepstakes begins at 12:00:00 AM Central Time (“CT”) on June 5, 2020 and ends at 11:59:59 PM CT on September 30, 2020 (“Sweepstakes Period”). The Sweepstakes Period will be broken out into four (4) monthly drawing periods (each, a “Drawing Period”) as set forth in the Monthly Entry, Drawing & First Prize Chart below.

- How to Enter:** To enter, visit the Casio page on Facebook (“Web site”) during any Drawing Period to find and complete the entry form, which includes your name, email address, date of birth, state where you reside, zip code, and daytime telephone number. Once you have completed the entry form, click “submit” to be entered into the Random Drawing. Limit one (1) entry per person/email address via this method of entry. However, to receive additional entries in the Sweepstakes, upon submitting your entry form, you will be shown options to share the Sweepstakes through Twitter, email or Facebook and for each referred friend who successfully submits and entry form, you will receive one (1) additional entry into the Sweepstakes.
