

## Official Rules – American Refugee Committee “Trip for Two to do the Doable!” Sweepstakes

### NO PURCHASE NECESSARY.

### PURCHASE WILL NOT IMPROVE CHANCES OF WINNING

1. **Sweepstakes Period:** You can enter the American Refugee Committee’s “Trip for Two to do the Doable!” Sweepstakes (“Sweepstakes”) beginning at 02:00:00 AM Central Time (“CT”) on August 13, 2018 and ending at 11:59:59 PM CT on September 9, 2018 (“Sweepstakes Period”):
2. **How to Enter:** There are two (2) ways to enter the Sweepstakes:
  - i. **ARC Facebook Page:** To enter via Facebook, visit the American Refugee Committee page on Facebook (“Website”) during the Sweepstakes Period, to find and complete the entry form, which includes your name, email address, date of birth, state where you reside, zip code, and daytime telephone number. Once you have completed the entry form, click “submit” to be entered into the Sweepstakes random drawing.
  - ii. **Radio Stream Rewards:** To enter via a radio stream rewards, listeners must first register on their applicable radio stream player as defined in Official Rule #12 (each, a “Stream Player” or collectively, the “Stream Players”), or if a listener is a current registered user, must first log into their account on the Stream Player’s website or App. Then, listen through your Stream Player (either online or through the applicable Stream Player App) during the Sweepstakes Period, and for every one (1) hour or more you listen through your Stream Player in any given day during the Sweepstakes Period, you will be eligible to receive one (1) entry into the random drawing. For purposes of this Sweepstakes, a day shall be defined as beginning at 12:00:00 AM CT and ending at 11:59:59 PM CT each day throughout the Sweepstakes Period (each, a “Day”). To be entered, **each registered listener must also complete and submit an online entry form** found at the “Trip for Two to the Doable!” rewards detail page.

All entries must be received by 11:59:59 PM CT on September 9, 2018 to be entered into the Random Drawing. **Limit of one (1) entry per person per day, regardless of the method of entry (and regardless of the number of hours each listener may listen per Day).**

This Sweepstakes is not sponsored, endorsed, administered by or associated with Facebook. By entering, you are providing your information to Sponsor and not to Facebook.

3. **Random Drawing:** A random drawing will be conducted on or about September 11, 2018 from among all eligible entries received to determine the Grand Prize winner. Decisions of judges are final and binding. Odds of winning the Grand Prize depend on the total number of entries received during the Sweepstakes Period. Administrator will conduct the random drawing. Winner will be notified by telephone, or email on or about the date of the drawing. Administrator will make up to **3 attempts** to contact the

potential Grand Prize winner. If the potential Grand Prize winner cannot be contacted after 3 attempts, that potential winner will forfeit his/her right to the Grand Prize, and an alternate Grand Prize winner will be selected, time permitting. Potential Grand Prize winner will be required to complete, sign and return an Affidavit of Eligibility, Liability Release and Publicity Release (where legal) (collectively, the "Prize Releases"), within **10 business days** of receipt of such Prize Releases. Winner will also be required to sign and complete a W9 prior to receiving their prize, and a 1099 form will be submitted by Sponsor (or Administrator, on behalf of the Sponsor) to all appropriate taxing authorities. These documents may require that you provide your Social Security Number for tax reporting purposes. Non-compliance with this requirement, or if prize/prize notification is returned as non-deliverable, or if any winner is found to be ineligible or not in compliance with these Official Rules, such prize will be forfeited and may be awarded to an alternate winner, time permitting. Upon receipt of all Prize Releases, Sponsor will contact the Grand Prize winner to arrange for travel arrangements.

4. **Prize & Approximate Retail Values ("ARV"):** **One (1) Grand Prize** – Trip for two (2) people to Nyabiheke Refugee Camp in eastern Rwanda with the American Refugee Committee **from January 19, 2019 through January 26, 2019**. Trip includes: roundtrip coach airfare from the Sponsor-specified major airport nearest winner's residence to Rwanda; seven (7) nights hotel accommodations for two people (one standard room, double occupancy); ground transportation to/from airport/hotel in Rwanda; visa costs for winner and guest; and breakfast, lunch and dinner each day for winner and guest for seven (7) days; ARV: \$5,000.00. Must present a valid credit card upon check-in at hotel. Alcohol, souvenirs/gifts, medical exam, inoculation/vaccination costs, and any other costs or fees not specified in these Official Rules are not included as part of the prize and are winner's and winner's guest's sole responsibility. **Receiving a medical exam and inoculations/vaccinations are required as a condition to accept the prize and travel to Rwanda as the Grand Prize winner and winner's guest.** A visa will be required for winner and winner's guest as a condition of receiving the prize and Sponsor will assist winner and winner's guest in obtaining the visa, as well as reimburse winner and winner's guest for any fees associated with receiving a visa to travel to Rwanda. A valid passport will also be required to travel. Winner and winner's guest must travel from January 19, 2019 through January 26, 2019 or prize will be forfeited and could be awarded to an alternate, time permitting, unless otherwise agreed to by Sponsor in writing. Prize only consists of the items specifically listed as part of the prize. Winner's travel companion must be at least 21 years of age or older. Winner and travel companion must travel on the same itinerary and have valid passports in order to travel to Rwanda. No cash or other substitution allowed by winner, but Sponsor may substitute the prize, or any portion thereof, for a prize of equal or greater value at Sponsor's sole discretion for any reason. The prize is non-assignable and non-transferable. Grand Prize winner is solely responsible for local, state and federal taxes on the prize..
