

**Garage Solutions Minneapolis & Driveway Envy's
"Signed, Sealed, Decluttered" Sweepstakes
Official Rules**

**NO PURCHASE NECESSARY
PURCHASE WILL NOT IMPROVE CHANCES OF WINNING**

1. **How to Enter:** To enter, visit the Driveway Envy or Garage Solutions Minneapolis page on Facebook ("Websites") from 9:00:00 a.m. Central Time ("CT") on August 22, 2019 through 11:59:59 p.m. CT on September 19, 2019 ("Sweepstake Period"), find and complete the entry form, which includes your name, email address, date of birth, state where you reside, zip code, and daytime telephone number. Once you have completed the entry form, click "submit" to be entered into the Random Drawing. Limit one (1) entry per person/email address per Website (for a total of two (2) entries during the entire Sweepstakes Period). However, to receive additional entries in the Sweepstakes, upon submitting your entry form, you will be shown options to share the Sweepstakes through Twitter, email or Facebook and for each referred friend who successfully submits and entry form, you will receive one (1) additional entry into the Sweepstakes. All entries must be received by 11:59:59 p.m. CT on September 19, 2019 to be entered into the Random Drawing.

This Sweepstakes is not sponsored, endorsed, administered by or associated with Facebook. By entering, you are providing your information to Sponsors and not to Facebook.

2. **Random Drawing:** A random drawing will be conducted on or about September 20, 2019, from among all eligible entries received to determine the winner. Decisions of judges are final and binding. Odds of winning depend on the number of entries received. Administrator will conduct the random drawing. Winner will be notified by telephone, or email on or about the date of the drawing. Administrator will make up to 3 attempts to contact each winner. If any winner cannot be contacted after 3 attempts, that potential winner will forfeit the prize, and the prize may be awarded to an alternate winner, time permitting.

Void where prohibited.

By entering the Sweepstakes, each entrant agrees that Sponsors may also send each entrant marketing and advertising emails about Sponsors products and services.

8. **General Conditions:** Sponsors reserve the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, for any reason whatsoever, including, without limitation, fire, flood, natural or man-made epidemic of health of other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis, order of any court or jurisdiction or if any fraud, technical failures or any other factor beyond Sponsors' reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsors in their sole discretion. If the Sweepstakes is terminated before the designated end date, Sponsors will (if possible) select the Grand Prize Winners in a random drawing from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances.
