

Official Rules – Minnesota Re-Bath Ugly Bathroom Contest (“Sweepstakes”)

Then, upload a photograph of your ugly bathroom (“Photo”). Once you have completed and submitted the entry form and Photo, you will receive one (1) entry into the Random Drawing. **Limit:** one (1) entry per person. Anyone attempting to get more than one (1) entry will be disqualified from the entire Sweepstakes.
