

# Official Rules – Old Dutch x Saint Paul Saints Giveaway Comment Sweepstakes

NO PURCHASE NECESSARY.

PURCHASE WILL NOT IMPROVE CHANCES OF WINNING

1. When to Enter: You may enter the Old Dutch x Saint Paul Saints Comment Sweepstakes (“Sweepstakes”) from 12:00 PM Central Time (“CT”) on May 4th, 2023 through 11:59:59 PM CT on May 31st, 2023 (“Sweepstakes Period”).

2. How to Enter: To enter, visit the Old Dutch Foods page on Facebook or Instagram Pages (“Website”) during the Sweepstakes Period, and comment on the “Old Dutch x Saint Paul Saints Giveaway” posts from May 4th, 2023 OR May 29th, 2023 by answering the question in the post to receive one (1) automatic entry into the Random Drawing.

All answers/comments must be posted by 11:59:59 PM CT on May 31st, 2023 to be entered into the Random Drawing. Limit: one (1) entry per person/email address. Anyone attempting to get more than one (1) entry may be disqualified from the entire Sweepstakes at Sponsor’s sole discretion.

This Sweepstakes is not sponsored, endorsed, administered by or associated with Facebook. By entering, you are providing your information to Sponsor and not to Facebook.

3. Random Drawing: A random drawing will be conducted on or about June 1st, 2023 to select one (1) Grand Prize winner from among all eligible entries

received. Decisions of judges are final and binding. Odds of winning depend on the number of entries received. Administrator will conduct the random drawing. Grand Prize winners will be notified by direct message or email on or about the date of the drawing. Administrator will make up to 2 attempts to contact each winner. If the Administrator is unable to reach any potential winner after 2 attempts, that potential winner will forfeit the prize, and the prize may be awarded to an alternate winner, time permitting. Sponsor is not responsible for direct messages not received or checked by any potential winner.

4. Claiming Your Prize: Upon winner verification, Sponsor will contact and mail out the Grand Prize to winner. Allow 2-4 weeks or mailing of any Grand Prize. 6. Eligibility: Open and offered only to legal residents of Minnesota, Wisconsin, North Dakota, South Dakota, and Iowa, who are 18 years of age or older. Void outside of MN, WI, ND, SD, IA, and where prohibited. Employees and directors of Old Dutch Foods, Ltd. General Conditions: Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, for any reason whatsoever, including, without limitation, fire, flood, natural or man-made epidemic of health of other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis, order of any court or jurisdiction or if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. If the Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select the Grand Prize Winners in a random drawing from all eligible, non-suspect entries received as of the date of

the event giving rise to the termination. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision.
