2. **How to Enter:** To enter, visit the Old Home Foods page on Facebook ("Web site") during the Sweepstakes Period to find and complete the entry form, which includes **your name**, **email address**, **date of birth**, **state where you reside**, **zip code**, and **daytime telephone number** and click "submit" to be entered into the Random Drawing. Limit one (1) entry per person/email address via this method of entry.
