

Official Rules – Old Home Foods’ End of Summer Sweepstakes

2. **How to Enter:** To enter, visit the Old Home Foods page on Facebook (“Web site”) during the Sweepstakes Period to find and complete the entry form, which includes **your name, email address, date of birth, state where you reside, zip code, and daytime telephone number** and click “submit” to be entered into the Random Drawing. Limit one (1) entry per person/email address via this method of entry. All entries must be received by 11:59:59 p.m. CT on the End date listed in the Entry Pools Chart in Official Rule #1 above to be entered into that Entry Pool, or by 11:59:59 p.m. CT on September 17, 2017 to be entered into the final Entry Pool random drawing.
