

## Official Rules – Old Home Foods Recipe Sweepstakes

1. **When to Enter:** You may enter the Old Home Foods Recipe Sweepstakes (“Sweepstakes”) from 10:30 a.m. on November 22, 2016 through 11:59:59 p.m. CT on February 7, 2017 (“Sweepstakes Period”). The Sweepstakes Period will be broken out into four (4) separate entry periods, (each, an “Entry Pool”), as follows:

2. **How to Enter:** To enter, visit the Old Home Foods page on Facebook (“Web site”) during the Sweepstakes Period to find and complete the entry form, which includes your name, email address, date of birth, state where you reside, zip code, and daytime telephone number. Once you have completed the entry form, you will also be required to submit the your favorite simple recipe (that contains at least **4 ingredients**) you make using at least one Old Home Foods product (“Recipe”), and upload a photograph of the finished dish and click “submit” to be entered into the Random Drawing. Limit one (1) entry per person/email address via this method of entry. **PLEASE NOTE:** Photograph submission is not required to enter. No actual Old Home product purchase is required. Notwithstanding the foregoing, all Recipes must list at least one Old Home product and include a minimum of 4 ingredients in order to be eligible. Recipe must be original to the entrant and not have been published in any other manner, including a contest or sweepstakes. All entries must be received by 11:59:59 p.m. CT on the End date listed in the Entry Pools Chart in Official Rule #1 above to be entered into that Entry Pool, or by 11:59:59 p.m. CT on February 7, 2017 to be entered into the final Entry Pool random drawing.

3. **Random Drawings:** A series of random drawings will be conducted on or about the Drawing Dates listed in the Entry Pools Chart in Official Rule #1 above, from among all eligible entries received in that particular Entry Pool to determine the winner(s).
