SKOR North- "\$10k Grand Slam" SWEEPSTAKES Official Rules

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING, VOID WHERE PROHIBITED BY LAW.

BY ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.

- 1. **Eligibility:** The SKOR North \$10k Grand Slam Sweepstakes (the "Sweepstakes") is open only to individuals who are 18 years or older and residents of Minnesota or Wisconsin and who reside within 150 miles of SKOR North's studio located at 3415 University Avenue, St. Paul, MN 55114, to be eligible to win. - 2. **Sweepstakes Period:** The Sweepstakes begins on at 12:00:00 AM Central Time ("CT") on September 30, 2019 and ends when and if a Minnesota Twins ("Twins") baseball player hits a home run ("Home Run") during the 2019-20 Major League Baseball ("MLB") play-offs (the "Sweepstakes Period").
- 3. **How to Enter:** To enter, you must download the SKOR North mobile app (the "App") from your app marketplace to your iPhone, iPad or Android device, and open the app on your smartphone or iPad. Upon opening the App, you will find the Sweepstakes tile. Select the Sweepstakes tile to find the entry form asking for your name, email address, date of birth, address, daytime telephone number, and asking you to predict which Twins player (by providing the player's first and last name) will hit the FIRST Home Run during the 2019-20 MLB Playoffs. Once you have completed the entry form and mad your prediction, click "submit" to be entered. Limit **one (1) entry/prediction** per person/email address during the entire Sweepstakes Period.
- 4. How to Win/Random Drawing: On or about the business day following the Home Run, all entries that contained the <u>correct prediction</u> by accurately naming the Twins player that actually hit the first Home Run during the 2019-20 playoffs will be put into a random drawing. Then, Sponsor will randomly select one (1) entry to be the Grand Prize winner, from among all entries that contained the correct prediction and named the Twins player that actually hit the first Home Run (as verified by the official MLB scorer) during the 2019-20 playoffs. Odds of winning depend on the number of entries received that contained the correct prediction by naming the Twins player that actually hit the first recorded Home Run.

The Grand Prize winner will be notified by Sponsor via email or telephone the day of the random drawing. Failure to respond to the email notification within **three (3) days** will be deemed forfeiture of the Prize and an alternate winner may be selected at Sponsor's sole

discretion, time permitting. Sponsor is not responsible for email or telephone notifications that are undeliverable.

5. **Prize & Approximate Retail Value)** ("ARV"): **One (1) Grand Prize -** The Grand Prize winner will receive EITHER: (1) \$1,000.00 cash award **OR** (2) \$10,000.00 but ONLY IF THE FOLLOWING CONDITIONS ARE MET: (i) the Grand Prize winner correctly predicted the Twins player that actually hit the first Home Run during the 2019-20 MLB Playoffs; AND (ii) the first Home Run is also a Grand Slam (meaning, a home run hit by a player in the course of a MLB playoff game with three (3) runners currently on base at the time of said home run), and (iii) if the first Home Run is **certified** as a Grand Slam *and* certified as the first home run hit by a Twins player during the MLB regular season and recorded as such as an official statistic. The ARV of the Grand Prize is **EITHER** \$1,000.00 **OR** \$10,000.00.

No prize transfer or cash substitutes allowed except at Sponsor's sole discretion due to prize unavailability or for any reason and only then for prize of equal or greater value. local government law, order, or regulation, public health crisis, order of any court or jurisdiction or if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. - 9. **Limitations of Liability:** The Released Parties as set forth above are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited to, malfunctions, interruptions or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the participation process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of phone calls; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any Prize.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with this Sweepstakes shall be governed by, and construed in accordance with, the laws of the State of Minnesota without giving effect to any choice of law or conflict of law rules (whether of State of Minnesota or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Minnesota.
