Official Rules

 - a. Follow <u>@SKORNorth</u> on Twitter and ensure your Tweets are visible to the public.

During any 2019-20 Minnesota Vikings regular season plus the four (4) scheduled playoff games, tweet the last name of the Minnesota offensive football player you predict will be the first to score a touchdown in that game, along with the hashtag **#FirstSKORChallenge**. Predictions must be tweeted out prior to the kickoff in each game ("Entry Deadline") in order to be eligible for that game's random drawing. Tweets received after the kickoff of any game will not be considered.
 - c. Include the hashtag **#FirstSKORChallenge** in your Tweet (along with the last name of the offensive player), so the Tweets look like: PlayerLastName #FirstSKORChallenge.
