

**SKOR North & Twin Cities Savers – Win a Pair of VIP Tickets to the Purple Daily Draft Party
Sweepstakes Official Rules**

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

BY PARTICIPATING IN THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.

- 1. Eligibility:** The SKOR North and Twin Cities Savers – “Win a Pair of VIP Tickets to the Purple Daily Draft Party Sweepstakes (the “Sweepstakes”) is open only to individuals who are 18 years or older and residents of Minnesota or Wisconsin who receive an email from Twin Cities Savers inviting them to enter the Sweepstakes (“Email Invite”) and who reside within 150 miles from the KSTP-AM, LLC studios at 3415 University Ave, St. Paul, MN 55114 (“Sponsor”). In order to be eligible to win a prize in this Sweepstakes, you cannot have won any prize or combination of prizes with a total stated value of \$600.00 or more from SKOR North within 60 days prior to the awarding of a prize to you in this Sweepstakes. These restrictions apply even if you reject the prize. No purchase necessary to participate in this Sweepstakes. Employees of KSTP-AM, LLC, and its podcast “Purple Daily,” and its Twin Cities Savers program (the “Sponsor”), HBI Radio, LLC, or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Sweepstakes (collectively, with Sponsor, the “Released Parties”) and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members of each such employee are not eligible to win. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 2. Sweepstakes Period:** The Sweepstakes begins at 12:00:00 AM Central Time (“CT”) on April 8, 2026, and ends at 11:59:59 PM CT on April 15, 2026 (the “Sweepstakes Period”).
- 3. How to Enter:** To enter for a chance to win, find the Email Invite as defined in Official Rule #1. Find the link to the Sweepstakes entry for in the Email Invite and complete and submit the entry form by 11:59:59 PM CT on April 15, 2026 to receive one (1) entry into the Sweepstakes random drawing. Limit one (1) entry per person during the entire Sweepstakes Period.
- 4. How the Winner Is Selected:** On or about April 16, 2026, one (1) Grand Prize winner will be randomly selected from among all eligible entries received during the Sweepstakes Period. Odds of becoming the Grand Prize winner will depend on the number of eligible entries received during the entire Sweepstakes Period.

Decisions of Sponsor are final and binding. The potential winner will be notified by Sponsor via email or telephone on or about the day they are selected as the potential Grand Prize winner (“Winner Notification”) and the potential winner must reply to such Winner Notification to verify eligibility within **24 hours** of Sponsor's sending the Winner Notification message. Failure to respond to the Winner Notification within **24 hours** will be deemed forfeiture of the prize, and an alternate winner may be selected at Sponsor's sole discretion, time permitting. Sponsor may select up to three (3) alternate winners, at its sole discretion. In the event Sponsor is unable to award the Grand Prize after the initial potential winner and all three (3) alternate winners (if selected) fail to respond to the Winner Notification as required above, the Grand Prize will not be

awarded. Sponsor is not responsible for Winner Notifications that are undeliverable, not received, or go unanswered for any reason.

5. **Prize and Approximate Retail Value ("ARV") – One (1) Grand Prize – Two (2) VIP tickets** to the Purple Daily Draft Party on April 23, 2026, at Mystic Lake Casino and Hotel at 7:00 PM (VIP doors open at 4:00 PM). ARV: \$200.00. VIP tickets include hand-held Purple Daily Flag, priority seating (begins at 4:00 PM CT), a Purple Daily Snapback Hat, a Purple Daily "Before I Die" coasters, and exclusive pre-show meet and greet with Phil, Judd, Declan & Thor (begins at 4:00 PM CT).. The prize will be awarded only if the potential Grand Prize winner fully complies with these Official Rules.

Prize consists of only those items specifically listed as part of the prize. No other substitution allowed by winner, but Sponsor may substitute the prize, or any portion thereof, for a prize of equal or greater value at Sponsor's sole discretion for any reason. There is no retail value associated with the meet and greet portion of the prize. All local, state, and federal taxes on the prize are Winner's sole responsibility. Prize is non-assignable and non-transferable and not redeemable for cash.

The Grand Prize winner must meet the eligibility requirements as set forth in official rule #1. Winner may be required to sign a liability and/or publicity release ("Prize Release") prior to issuance of their Prize, if required by Sponsor in its sole discretion.

6. **Claiming the Prize:** Upon response to the Winner Notification, once verified, the Grand Prize winner will receive their Grand Prize via email. Sponsor is not responsible for misdirected or unanswered emails, or emails going to a SPAM or Junk folder, or any technical glitches associated with the emailing of the Grand Prize winner. Lost or stolen tickets will not be replaced.
7. **Participation Conditions/Release/Consent to use Likeness:** By participating, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) release and hold harmless the Released Parties from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to death or personal injury arising out of or relating to a participant's participation in this Sweepstakes and acceptance or use or misuse of a prize; (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorney's fees) arising out of or relating to an entrant's participation in the Sweepstakes and/or entrant's acceptance, use or misuse of prize; and (d) allow Sponsor's use for promotional purposes, of his/her likeness, voice and/or address (city/state) without any additional compensation.
8. **General Conditions:** Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, for any reason whatsoever, including, without limitation, fire, flood, natural or man-made epidemic of health or other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis, order of any court or jurisdiction or if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate

operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Only the type and quantity of prizes described in these Official Rules will be awarded. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

9. **Limitations of Liability:** The Released Parties as set forth above are not responsible for: (1) unauthorized human intervention in any part of the participation process or the Sweepstakes; or (2) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of the Grand Prize.
10. **Disputes/Governing Law:** Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or the prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate federal or state court of Minnesota; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with this Sweepstakes, but in no event attorneys' or legal fees; and (3) unless otherwise prohibited, under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with this Sweepstakes shall be governed by, and construed in accordance with, the laws of the State of Minnesota without giving effect to any choice of law or conflict of law rules (whether of State of Minnesota or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Minnesota.
