Official Rules**

**NO DONATION NECESSARY TO ENTER OR WIN; A DONATION WILL NOT IMPROVE
CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.**

BY ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.

1. **Eligibility:** The SKOR North Support Ronald McDonald House Charities Upper Midwest Luis Arraez Jersey Giveaway (the "Sweepstakes") is open only to individuals who are 18 years or older and residents of Minnesota or Wisconsin who reside within 30 miles of SKOR North's studio located at 3415 University Avenue, St. Paul, MN 55114. No purchase necessary to enter the Sweepstakes. Employees of KSTP-AM, LLC and its radio station SKOR North (the "Sponsor"), HBI Radio, LLC, or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Sweepstakes (collectively with Sponsor, the "Released Parties") and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members of each such employee are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. 2. **Sweepstakes Period:** The Sweepstakes will begin at 12:00 PM Central Time ("CT") (noon) on March 24, 2020 and ends at 3:00:00 PM CT on April 10, 2020 ("Sweepstakes Period").
3. **How to Enter:** To enter, visit SKORNorth.com ("Website") and click on "Help SKOR North Support Ronald McDonald House Charities Upper Midwest" banner, or enter the keyword "DONATE" on the website in the search bar. Then, make a donation of any amount to receive one (1) automatic entry into the Sweepstakes random drawing; or to enter without making a donation, by emailing rbrendel@skornorth.com, with your complete name, telephone number and email address in the body of the email, and "Ronald McDonald Giveaway" in the Subject line of the email. All entries must be received by 3:00:00 PM CT on April 10, 2020 to be entered into the random drawing.
4. **Random Drawing:** A random drawing will be conducted by Sponsor on or about April 11, 2020 from among all eligible automatic and email entries received during the Sweepstakes Period, to determine the Grand Prize winner. Odds of being named the Grand Prize winner depend on the number of eligible entries received. Decisions of judges are final and binding. The Grand Prize winner will be notified by telephone or email on or about the day of the random drawing. Sponsor will make up to **2 attempts** to contact the potential Grand Prize winner. If Sponsor is unable to contact the potential Grand Prize winner after 2 attempts, that potential Grand Prize winner will forfeit the Grand Prize, and the prize will be awarded to an alternate winner from among all remaining entries received.
5. **Prize and Approximate Retail Value ("ARV") - One (1) Grand Prize:** A signed Luis Arraez, Minnesota Twin jersey. The jersey was donated by the Minnesota Twins. ARV: \$150.00. Autograph is subject to availability. Value of autographed items may fluctuate with market conditions. Sponsor makes no representations or warranties that autographed items may be sold, bartered or exchanged for any value stated herein.

Prize consists of only those items specifically listed as part of the prize. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other Sweepstakes or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.
