

**SKOR North/myTalk 107.1/KS95/Garage Logic Podcast
"Pick Your Prize" Sweepstakes
Official Rules**

- 1. Eligibility:** The "SKOR North/myTalk 107.1/KS95/Garage Logic Podcast Pick Your Prize" Sweepstakes (the "Sweepstakes") is open only to individuals who are 21 years or older and residents of Minnesota or Wisconsin and who reside within 150 miles of SKOR North/myTalk 107.1/KS95/Garage Logic Podcast studios located at 3415 University Avenue, St. Paul, MN 55114, to be eligible to win. In order to be eligible to win a prize in this Sweepstakes, you cannot have won any prize or combination of prizes with a total stated value of \$600.00 or more from SKOR North, myTalk 107.1 KS95, or the Garage Logic Podcast within 60 days prior to the awarding of a prize to you in this Sweepstakes. These restrictions apply even if you reject the prize. No purchase necessary to enter the Sweepstakes.  - a. KS95 Method of Entry:** There are **two (2)** methods of entry for KS95.

 - 1) KS95.com:** To enter via this method of entry, visit www.ks95.com (a "Website"), find the Contest page to find the *Pick Your Prize Sweepstakes* online entry form. Then, complete and submit the entry form to receive one (1) entry into the KS95 Semi-Finalists random drawing pool, as described in Official Rule 4 (d) below. Limit one (1)

entry per person per day via this method of entry. **Please note**, the only way to be entered into the Grand Prize random drawing for a chance to win the Grand Prize is to be selected and deemed a Semi-Finalist (either by being selected in the KS95 Semi-Finalist random drawing, by becoming a Semi-Finalist as set forth in the KS95 On-Air method of entry set forth below, or by becoming a Semi-Finalist via the other stations' methods of entry).

- 2) **KS95 On-Air:** This is a listen-to-win method of entry. To enter via the KS95 On-Air method of entry, listen to KS95 weekdays (Monday – Friday) from 3/16/26 – 3/27/26 every hour for the **“Pick Your Prize”** cue-to-call to air between 9:00 a.m. CT and 6:00 p.m. CT. Upon hearing the **Pick Your Prize** cue-to-call, be the ninth (9th) caller to reach the station by calling **651-989-KS95 (5795)** to receive a \$100.00 cash/check and be deemed a qualifier (each, a “Qualifier”). There will be 90 Qualifiers during the entire Sweepstakes Period via this KS95 On-Air method of entry. Then, if that Qualifier is also a KS95 Listener Rewards Member, that Qualifier will receive an additional \$100.00 cash/check and be deemed a Semi-Finalist and will be automatically entered into the Grand Prize random drawing for a chance to win the Grand Prize. KS95 is not responsible for problems accessing the phone line that may disrupt the completion of the entry, or any other problems which might or might not result from this Contest. By calling into the station, you agree to be recorded and have your likeness broadcast on-air. Limit one (1) Qualifier per person during the entire Sweepstakes Period. If the Qualifier is not a KS95 Listener Rewards Member at the time they are deemed a Qualifier, then that person will NOT be deemed a Semi-Finalist, and will not be included in the Grand Prize random drawing.

In the event less than 90 of the Qualifiers are also deemed a Semi-Finalist per the preceding paragraph, then Sponsor will select Semi-Finalists via a random drawing, which will occur on or about 3/31/26 from among all current KS95 Listener Rewards Members who entered the Sweepstakes via the KS95.com method of entry as set forth in Official Rule 3 (a) (1) above, until it reaches a total of 90 Semi-Finalists, who will each be included in the Grand Prize Random Drawing for a chance to win the Grand Prize.

- b. **SKOR North, myTalk 107.1, and Garage Logic Method of Entry:** To enter via any of these methods of entry, visit one of the following websites; www.SKORNorth.com, www.mytalk107.1.com or www.garagelogic.com (each, a “Website”), find the Contest page on the Website to find the *Pick Your Prize Sweepstakes* online entry form. Then, complete and submit the entry form to receive one (1) entry into the specific Station's Semi-Finalists random drawing pool, depending on the Station's Website you entered through. **Please note:** each Website will have its own separate Semi-Finalist random drawing, then at the end of the Sweepstakes Period, all Semi-Finalists will be entered into the Grand Prize random drawing. The only way to be entered

into the Grand Prize random drawing is to be deemed a Semi-Finalist. Limit one (1) entry per person per day per Website via this method of entry.

c. How to receive Bonus Entries:

1) **Station App:** To receive an App bonus entry, after entering via the initial method of entry (as set forth in section 3 a) and/or b) above), you will also be provided an opportunity to download the SKOR North, KS95 and/or myTalk 107.1 mobile app (each, an “App”). For each App you download, you will receive one (1) bonus entry into the specific Station’s Semi-Finalists random drawing pool, depending on the Station’s Website you entered through initially. If you already have the App, simply click/open the App to receive the App bonus entry. Limit one (1) App bonus entry per App (for a total of up to three (3) App bonus entries) during the entire Sweepstakes Period.

3) **Refer-A-Friend Bonus Entries:** To receive Refer-A-Friend bonus entries, after entering via the initial online method of entry (as set forth in Official Rule 3 a) and/or b) above), you will also be provided an ongoing opportunity to Refer-A-Friend to participate in the Sweepstakes. If you click the link to “Refer-A-Friend” as provided on the Sweepstakes page of each Website during the Sweepstakes Period, and if that friend enters the Sweepstakes ***through your personal unique entry URL provided to you when you entered your friend’s name***, you will receive ***five (5)*** Refer-A-Friend bonus entries into the specific Station’s Semi-Finalists random drawing pool, depending on the Station’s Website you entered through initially, for ***each*** friend you refer that enters via this method of entry. There is no limit to the number of friends you can refer.

9:00 a.m. CT, from among all eligible entries received through the SKOR North entry form up to the date of each random drawing (for a total of 10 Semi-Finalists for the entire Sweepstakes Period via this method of entry). Odds of being selected as a Semi-Finalist depend on the number of eligible entries received up to each random drawing through the SKOR North Website. Any non-winning entries from any random drawing WILL roll over to subsequent random drawings. Each Semi-Finalist will receive a \$100.00 cash/check and will automatically be entered into the Grand Prize Random Drawing, upon winner notification and verification. Each Semi-Finalist will be notified by telephone, or email on or about the date of the applicable drawing. Odds of being selected as a Semi-Finalist depend on the number of eligible entries received up to each random drawing through the myTalk 107.1 Website. Any non-winning entries from any random drawing WILL roll over to subsequent random drawings. Each Semi-Finalist will receive a \$100.00 cash/check and will automatically be entered into the Grand Prize Random Drawing, upon winner notification and verification. Each Semi-Finalist will be notified by telephone, or email on or about the date of the applicable drawing. KS95 Semi-Finalists Random Drawing:** On 3/27/26, one (1) semi-finalist (“Semi-Finalist”) will be randomly selected by Sponsor at or about 9:00 a.m. CT from among all eligible entries received through the KS95 Website during the Sweepstakes Period. Odds of being selected as the Semi-Finalist depends

on the number of eligible entries received through the KS95 Website up to the time of the random drawing. The Semi-Finalist will automatically be entered into the Grand Prize Random Drawing.

- e. **Grand Prize Random Drawing:** On 3/31/26, one (1) grand prize winner (“Grand Prize Winner”) will be randomly selected by Sponsor at or about 9:00 a.m. CT from among all eligible Semi-Finalists. Odds of winning the Grand Prize are up to 1:146. The potential Grand Prize Winner will be notified by telephone, or email on or about the date of the drawing. Sponsor will make up to 3 attempts to contact the potential Grand Prize Winner. i.
