

**Official Rules Dove Men + Care Ticket to Minny Sweepstakes
(NCAA Men's Basketball Final Four)**

**NO PURCHASE NECESSARY.
PURCHASE WILL NOT IMPROVE CHANCES OF WINNING**

1. **When to Enter:** You may enter Dove Men + Care Ticket to Minny Sweepstakes ("Sweepstakes") from 12:00:00 AM Central Time ("CT") on February 11, 2019 through 11:59:59 PM CT on March 24, 2019 ("Sweepstakes Period").
2. **How to Enter:** To enter, visit www.hoopscontest.com ("Website") during the Sweepstakes Period, and complete the entry form, which includes your name, email address and daytime telephone number, and a space to share your favorite NCAA basketball Final Four memory (up to 150 characters) (collectively, the "Entry Form"). Once you have completed the Entry Form, click "submit" to be entered into the random drawing. Limit one (1) entry per person/email address for the entire Sweepstakes Period. All entries must be received by 11:59:59 p.m. CT on the March 24, 2019.
3. **Random Drawing:** A random drawing will be conducted on or about March 25, 2019 from among all eligible entries received. Decisions of judges are final and binding. Odds of winning depend on the number of entries received. Sponsor will conduct the random drawing. Winners will be notified by telephone, or email on or about the date of the drawing. Sponsor will make up to **2 attempts** to contact a winner. If a winner cannot be contacted after 2 attempts, that potential winner will forfeit the prize, and the prize may be awarded to an alternate winner, time permitting.
