

**Zerorez Spring Into Clean Sweepstakes
Official Rules**

PLEASE NOTE: Potential winner must live within a **30-mile radius** of the Zerorez's St. Louis Park location located at 5310 W 23rd St #100, St Louis Park, MN 55416 in order to not be charged a service fee.

- 1. How to Enter:** The Zerorez Spring Into Clean Sweepstakes ("Sweepstakes") begins at 9:00 AM Central Time ("CT") on April 6, 2018 and ends at 11:59:59 p.m. CT on April 26, 2018 ("Sweepstakes Period"). To enter, visit the Zerorez page on Facebook during the Sweepstakes Period, to find, complete and submit the Sweepstakes online entry form, which includes your name, email address, address and telephone number. Upon submitting the online entry form, each eligible entrant will receive one (1) entry into the random drawing. All online entries must be submitted by 11:59:59 PM CT on April 26, 2018 to be eligible for the random drawing. **Limit:** one (1) entry per person, per day, regardless of the method of entry. Anyone attempting to get more than one (1) entry may be disqualified from the entire Sweepstakes, at Sponsor's sole discretion. However, to receive additional entries, upon submitting your entry form, you will see "Get More Entries" where entrants can refer a friend by sharing the Sweepstakes through Facebook, Twitter, email or sending a direct link. For each referred friend who successfully submits and entry form, you will receive one (1) additional entry into the random drawing. All entries must be received by 11:59:59 p.m. CT on April 26, 2018 to be entered into the random drawing.

This Sweepstakes is not sponsored, endorsed, administered by or associated with Facebook. By entering, you are providing the information to Sponsor, and not to Facebook.

- 2. HOW THE WINNER IS SELECTED & NOTIFIED:** A random drawing will be conducted by Administrator on or about April 30, 2018, from among all eligible entries received, to determine one (1) Grand Prize winner. Decisions of judges are final and binding. Odds of winning depend on the number of eligible entries are received. Administrator will conduct the random drawing. Winner will be notified by telephone, or email on or about the date of the drawing. Administrator will make up to **3 attempts** to contact the winner. Void outside of Louisiana and Alabama, and where prohibited.

local government law, order, or regulation, public health crisis, order of any court or jurisdiction or if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. If the Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select the Grand Prize Winners in a random drawing from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner.
