

## Official Rules – Ticket King Tickets to Gopher Football Game Sweepstakes

### NO PURCHASE NECESSARY. PURCHASE WILL NOT IMPROVE CHANCES OF WINNING

1. **How to Enter:** To enter, visit the Ticket King page on Facebook (“Web site”) from 12:00:00 p.m. Central Time (“CT”) on September 21, 2017 until 11:59:59 p.m. CT on October 12, 2017 find and complete the entry form, which includes your name, email address, date of birth, state where you reside, zip code, and daytime telephone number. Once you have completed the entry form, click “submit” to be entered into the Random Drawing. Limit one (1) entry per person/email address via this method of entry. However, to receive additional entries in the Sweepstakes, upon submitting your entry form, you will be shown options to share the Sweepstakes through Twitter, email or Facebook and for each referred friend who successfully submits and entry form, you will receive one (1) additional entry into the Sweepstakes.
