

## Official Rules – KS95 Grandview Lodge North July Facebook Giveaway

### NO PURCHASE NECESSARY. PURCHASE WILL NOT IMPROVE CHANCES OF WINNING

1. **When to Enter:** You may enter the KS95 “Grandview Lodge North July Facebook Giveaway” (“Sweepstakes”) from 12:00:00 AM Central Time (“CT”) on July 13, 2020 through 11:59:59 PM CT on July 29, 2020 (“Sweepstakes Period”).
2. **How to Enter:** To enter, during the Sweepstakes Period, visit the KS95 page on Facebook (the “Page”). Once on the Page, find and complete the entry form, which includes your name, email address, date of birth, state where you reside, zip code, and daytime telephone number. Once you have completed the entry form, click “submit” to be entered into the Random Drawing. Limit one (1) entry per person/email address via this method of entry. However, to receive additional entries in the Sweepstakes, upon submitting your entry form, you will be shown options to share the Sweepstakes through Twitter, email or Facebook and for each referred friend who successfully submits and entry form, you will receive one (1) additional entry into the Sweepstakes. All entries must be received by 11:59:59 PM CT on June 29, 2020, to be entered into the Random Drawing.

**This Sweepstakes is not sponsored, endorsed, administered by or associated with Facebook. By entering, you are providing your information to Sponsor and not to Facebook.**

3. **Grand Prize Random Drawing:** Then, a Grand Prize random drawing will be conducted on or about July 30, 2020 after 10:00 AM CT from among all eligible Qualifiers to select one (1) Grand Prize winner. Decisions of judges are final and binding. Odds of winning depend on the number of eligible entries received during the Sweepstakes Period. Administrator will conduct the random drawing. Grand Prize winner will be notified by telephone, or email on or about the date of the drawing. Administrator will make up to **2 attempts** to contact each winner. If a winner cannot be contacted after 2 attempts, that potential winner will forfeit the prize, and the prize may be awarded to an alternate winner, time permitting. Sponsor is not responsible for any winner notification that goes unanswered or is not received for any reason by any potential winner.
