KS95 – "WINTER WINNERLAND" SWEEPSTAKES Official Rules

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING, VOID WHERE PROHIBITED BY LAW.

BY ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.

- 1. **Eligibility:** The KS95 "Winter Winnerland" Sweepstakes (the "Sweepstakes") is open only to individuals who are 18 years or older (except for the Monday Daily Prize winners who must be 21 years of age or older) and residents of Minnesota or Wisconsin and who reside within 150 miles of KS95's studio located at 3415 University Avenue, St. Paul, MN 55114, to be eligible to win. No purchase necessary to enter the Sweepstakes. Employees of KSTP-FM, LLC and its radio station KS95 (the "Sponsor"), Chankaska Creek Ranch and Winery, Minnesota Zoo, Old Home Foods, Simonson's Salon & Spa, and Wild Mountain (collectively, the "Promotional Participants"), Hubbard Radio, LLC, or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Sweepstakes (collectively with Sponsor and Promotional Participants, the "Released Parties") and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members of each such employee are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. 3. **How to Enter:** To enter, visit the KS95 website at www.ks95.com ("Website") during any Weekly Entry Period to find the Contest tab to find the Sweepstakes tile to find and complete the entry form, which includes your name, email address, date of birth, state where you reside, zip code, and daytime telephone number. Once you have completed the entry form, click "submit" to receive one (1) entry into the Sweepstakes. **Limit one (1) entry per**

person/email address. However, to receive additional bonus entries in the Sweepstakes, upon submitting your entry form, select the "Bonus Form" button at the bottom of the entry form where you can earn a number of additional bonus entries into the random drawings ("Bonus Entries"). The specific number and limit of Bonus Entries allowed per person per method of entry is as specifically listed on the Website. All entries must be received by 11:59:59 p.m. CT on the last day of the Weekly Entry Pool as set forth in the Chart above to be entered into that week's Weekly Entry Pool Random Drawing, or by 11:59:59 PM CT each weekday to be entered into that weekday's Daily Random Drawing (as defined in Section 4 below).

Sponsor is not responsible for lost, late, incomplete, invalid or misdirected entries, which may be disqualified at Sponsor's sole discretion. 14 Thursday Daily Prize winners: A \$50.00 Simonson's Salon & Spa Gift Card. ARV: \$50.00 each. Gift card is subject to the terms, conditions and restrictions as printed on the card.

14 Friday Daily Prize winners: Two (2) lift tickets OR snow tubing passes to Wild Mountain in Taylor's Falls, MN. ARV: \$98.00. lift tickets OR snow tubing passes valid for the 2016-2017 ski season only, ends mid-March 2017. Tickets/passes are subject to the terms, conditions and restrictions as printed on the ticket. Transportation and equipment rental not included as part of the prize.

Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.
