

**KS95 WIN LEATHER AND LACES SPRING EDITION PARTY TICKETS SWEEPSTAKES**  
**Official Rules**

**NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.**

**BY ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.**

- 1. Eligibility:** The KS95 Win Leather and Laces Spring Edition Party Tickets Sweepstakes (the "Sweepstakes") is open only to individuals who are at least 21 years of age or older and residents of Minnesota and Wisconsin who reside within 150 miles from the KS95 Studios located at 3415 University Ave, St. Paul, MN 55114. In order to be eligible to win a prize in this Sweepstakes, you cannot have won any prize or combination of prizes with a total stated value of \$600.00 or more from KS95 within 60 days prior to the awarding of a prize to you in this Sweepstakes. - 4. Random Drawing** There will be two winners; a random drawing will be conducted after 9:15 AM on April 3, 2019, from among all eligible Entries received during the Sweepstakes Period to determine the two winners. Decisions of judges are final and binding. Odds of winning depend on the number of entries received. Administrator will conduct the random drawing. Grand Prize winner will be notified by direct message through Facebook on the date of the drawing. Administrator will make up to **2 attempts** to contact the winner. If the winner cannot be contacted after 2 attempts, that potential winner will forfeit the prize, and the prize may be awarded to an alternate winner, time permitting.

Tickets are subject to the terms, conditions and restrictions as printed on the tickets. The prize is non-assignable and non-transferable. Sponsor reserves the right, in its sole discretion, to substitute the prize for one of equal or greater value, for any reason. Prizes consist of only

those items specifically listed as part of the Prize. Winners are solely responsible for any local, state or federal taxes associated with the prize. A qualified winner must also meet the eligibility requirements as set forth in Paragraph 1 of these rules.
